#### RE-OPENING DELAWARE CHILD CARE SAFELY -A BLUEPRINT FOR SUPPORTING OUR EARLY CHILDHOOD EDUCATORS DURING COVID-19:

Compiled and maintained **updated health & safety guidance** for early childhood programs based on Delaware licensing regulations, state of emergency health requirements, and CDC recommendations.



Hosted a series of **webinars with health & safety panelists** to review current guidance and answer program questions.

### DELAWARE EARLY EDUCATION & CHILD CARE STABILIZATION FUND PROGRAM ADMINISTRATION:

Designed and implemented application, review, and verification processes to **support licensed child care centers and family child care programs** remaining open or temporarily closed due to COVID-19 to stay in business, addressing increased operational costs and reduced and inconsistent enrollment.

**\$88,142,925.22** approved for **885 programs**.

#### LAPTOP INITIATIVE:

Responding to the transition of many services to a virtual format and to families' restricted access to child care spaces, purchased and distributed **laptops and technology supports** for **100 early childhood programs** to assist early childhood professionals in communicating with families and accessing technical assistance, trainings, webinars, and coaching.

#### HEALTH SUPPLIES DISTRIBUTION:

Purchased and distributed cloth face coverings, hand sanitizer, notouch thermometers, and replacement batteries to 650 early "We are so thankful for all that Stars is doing and for thinking of us with the kits. We know Stars has had to make adjustments during the pandemic, so we are especially appreciative of their staff taking the time to put together the bags and delivering them to us."

childhood programs to support early childhood programs unable to obtain health & safety supplies necessary to remain open and serving children during the state of emergency.

Distributed **13,900 covid-19 tests** to early childhood programs throughout Delaware.

## ECE SCHOOL-AGE REMOTE LEARNING GRANT PROGRAM ADMINISTRATION:

Designed and implemented application, review, and verification processes to support licensed child care centers and family child care programs providing care to school-age children engaged in remote or hybrid learning to ease the burden of additional costs associated with providing a safe and productive environment for Delaware's schoolage remote learners-\$999,999.76 distributed to 152 programs.

#### ENHANCED REIMBURSEMENT SUPPORT:

Verified **6,821 applications** from early childhood programs participating in "enhanced reimbursement," the program designed to support licensed child care programs remaining open to serve children during the state of emergency, providing
